### "No one favors current status-quo in Nagorno-Karabakh conflict"

May 16 (AzerTAc). No one favored the current status-quo in Nagorno-Karabakh conflict, the chairperson of US House of Representatives Committee on Foreign Affairs Ileana Ros-Lehtinen said. Ros-Lehtinen underlined that Azerbaijan's role is increasing in exploration, development and transportation of energy resources. She welcomed diversification of energy transportation, and stressed that Baku-Tbilisi-Ceyhan pipeline has become a main transportation route which supplies the world with fuel. "It creates opportunity for the country to diversify the energy sources and our allies to avoid some dependence. New routes such as Nabucco will contribute to increase the strategic importance of Azerbaijan", Ros-Lehtinen stated. Ros-Lehtinen pointed out importance of expansion of economic and trade ties between the countries, and said that the third meeting within the framework of the US-Azerbaijan partnership held in Washington brought initiatives civil aviation. new to The Committee chairperson described Azerbaijan as a 'significant' partner of the US in the fight against force and extremism, and highlighted that there is a close cooperation between the US and Azerbaijan not only in the fields of prevention of terrorist attacks, but also proliferation of biological and nuclear weapons. "We are satisfied particularly with the exercises conducted for the security of the Caspian Sea". Ros-Lehtinen also expressed concern over the incidents occurred in the border areas with Nagorno-Karabakh. "Two Azerbaijani soldiers were killed tragically in the shooting. Use of force remains this prolonged conflict unsettled", added Ros-Lehtinen.

## European Commission releases annual report on Azerbaijan's development

May 16 (AzerTAc). The European Commission has published an annual report on Azerbaijan's development within the European Neighborhood Policy (ENP). The main aspects of cooperation between Azerbaijan and the EU in 2011 and the recommendations of the European Union regarding the different fields were reflected in the document.

The document says: "Azerbaijan is rapidly developing. It broadly maintained macroeconomic stability, reduced poverty and encouraged the diversification of the economy. Negotiations on the Nagorno-Karabakh conflict within the Minsk Group led to no tangible results in 2011. Amidst

increasing tension along the Line of Contact, mediation efforts resulted in marginal progress on the investigation of the violation of the ceasefire agreement.

### **Investment of Turkish companies increasing in Azerbaijan**

May 16 (AzerTAc). "The capacity of mutual investments between two brotherly countries, Azerbaijan and Turkey has been increasing year after year" said the trade advisor of the Turkish embassy to Azerbaijan Huseyn Yavuz Necip in the meeting that brought together the trade advisors of the neighboring countries' embassies. "It is pleasant that the capacity of the imports from Turkey takes second place after Russia" added Turkish trade advisor.

Huseyn Yavuz underlined currently 1266 Turkish companies have been operating in Azerbaijan. These companies have invested \$6.5 billion and employed over 25 thousand people. The volume of trade between the two countries has also reached \$3, 5 billion. "The sympathy of the Azerbaijanis to Turkey, the geographical closeness and mutual profits in the international arena are the factors of affecting the growth of trade between the two brotherly countries" Huseyn Yavuz stressed.

## Foreign ministry spokesman: Azerbaijan attaches particular importance to relations with neighboring states

May 17 (AzerTAc). Azerbaijan's foreign ministry spokesman has reaffirmed that the country puts a special emphasis on its relationship with neighboring Elman Abdullayev's statement came in response to a protest held in front of Azerbaijan's Consulate in Tabriz. He said Azerbaijan took into consideration the interests of neighboring countries, including Iran, in its foreign policy. Abdullayev underlined that Azerbaijan and Iran relations have had deep roots. The spokesman stressed threats, sabotages against democratic, secular Azerbaijan are 'unacceptable'. "The forces who speak of Islamic solidarity, religious fanaticism will not be able to undermines our country's increasing prestige with their lies and slanders." Abdullayev underlined that the protests held in front of Azerbaijan's diplomatic representations in Iran had been organized by the groups who try to derail the relations between the two countries. "The Azerbaijani side expresses deep concern over the increasing number of protests, and states that it is impossible to impact on Azerbaijan or achieve changes in the country's political course through this." "The most important problem for Azerbaijan is the continuing occupation of its territories by Armenia. The Muslim world and

several international organizations recognized Armenia as an aggressor, and condemned the Khojaly genocide committed by Armenians against Azerbaijanis. Unfortunately, our neighbor has not expressed its attitude towards these events".

The Foreign Ministry spokesman said: "Staging anti-Azerbaijani protests in Tabriz to make groundless claims against our country and make radical calls despite the fact that the Azerbaijani side has repeatedly reiterated that its territory can never be used for any aggression against Iran is nothing but hostility and craftiness. The activity of some forces in Iran who speak of Islamic solidarity, brotherhood is aimed at shattering stability in Azerbaijan." "What Islamic solidarity are they talking about if over a million of their religious brothers have been left homeless for more than 20 years by the aggressor Armenia, which Iran has been continuously supporting both materially and morally, if hundreds of Islamic temples were destroyed and robed bv the Armenian Abdulalyev added: "All this proves that what is going on in Iran against Azerbaijan is not a religious sympathy, instead, this campaign serves only to hostility, incitement and disrespect towards our national and cultural values."

### Azerbaijani President meets Prime Minister of Montenegro

May 20 (AzerTAc). President of Azerbaijan Ilham Aliyev, who is in Chicago for a working visit, has met Prime Minister of Montenegro Igor Luksic. They praised the development of the bilateral relations between Azerbaijan and Montenegro. They said the strengthening of political relations was boosting the bilateral cooperation in other areas, in particular in the economic one. President Ilham Aliyev and Igor Luksic said there were good prospects for cooperation in many fields, including energy, tourism and transport infrastructure. They expressed confidence the Azerbaijan-Montenegro relations would further expand.

### Azerbaijani President meets Slovenian Premier in Chicago

In a letter to the Congress chairman Sahil Gasimov, the Queen's personal secretary said Her Majesty was pleased to receive a congratulatory message and "Painting of Azerbaijan: Anthology" book from the Benelux Azerbaijanis Congress on the occasion of the Queen's Day.

## Report and draft resolution on Nagorno-Karabakh to be presented at OSCE PA summer session

May 20 (AzerTAc). A report on the Nagorno-Karabakh and a resulting draft resolution will be presented at OSCE Parliamentary Assembly's summer session in Monaco in July, said vice-speaker of Azerbaijan's Parliament and head of the country's delegation to OSCE PA Bahar Muradova. "Work is underway on the report and the draft resolution." She said a meeting with the Secretary General of OSCE PA, Spencer Oliver, which was held during the spring session, considered the issues that caused the Azerbaijani side's objections.

A report on the fulfillment of the Belgrade Declaration and OSCE PA resolutions will be heard at the session. The Monaco Declaration is also expected to be adopted.

The session will also discuss violations in the parliamentary elections in Armenia. The OSCE observation mission's report reflects a number of shortcomings that occurred during the parliamentary elections in Armenia. "The OSCE Parliamentary Assembly will consider not only the violations, but will assess them. Probably, this issue will be also considered during the session," Muradova added.

### President of Azerbaijan meets Premier of Great Britain

21 May (AzerTAc). President of Azerbaijan Ilham Aliyev being on a working visit in Chicago met here with the Prime Minister of the Great Britain David Cameron. Azerbaijani President and British Premier praised the development of bilateral relations between the two countries, confidence expressed for strengthening of relations and cooperation. Noting the fruitful results in energy cooperation between Azerbaijan and the Great Britain, the sides stressed joint efforts of Azerbaijani and British oil companies, in particular BP, to develop the "South" energy corridor. President Aliyev and Premier Cameron also discussed the state in Afghanistan, further cooperation to establish peace and safety in this country. A number of regional questions also were focused on in the meeting.

Azerbaijan's President attends meeting of heads of state and government on Afghanistan in Chicago

May 21 (AzerTAc). World leaders convened in Chicago on Monday after completing some of the most intensive negotiations of the year on issues ranging from eradicating hunger to resolution of the eurozone crisis and ending the Afghanistan war. President of Azerbaijan Ilham Aliyev participated in the meeting. The Azerbaijani President addressed the event. In the NATO communiqué, the heads of state and government claimed the withdrawal of international forces from Afghanistan was on track and "irreversible", and would provide a new non-combat NATO mission in Afghanistan after 2014 "to train, advise and assist" the Afghan army. Opening the meeting, NATO Secretary General Anders Fogh Rasmussen said here today discussed the future of the Afghan government and people. Speaking on the activities of the International Security Assistance Force in Afghanistan, NATO Secretary General pointed out that these forces have played an active role in the fight against terrorism. There is an ongoing process of devolution of NATO powers in Afghanistan to the country's police and military authorities. President Obama, after meeting Afghanistan president Hamid Karzai in Chicago on Sunday, insisted that within the next two years the war in Afghanistan as we know it would be over. President Barack Obama praised the operation in Afghanistan carried out by International Security Assistance Force, and noted that 75 percent of Afghanistan is controlled by the Afghans. Azerbaijan's President Ilham Aliyev addressed the meeting. The Head of Azerbaijani State said since the early years Azerbaijan has made every effort to ensure peace and security in Afghanistan. President Ilham Aliyev stressed Azerbaijan continues its mission and Azerbaijani servicemen are actively involved in peacekeeping operations in Afghanistan. In addition, Azerbaijan has also contributed to Afghanistan by carrying out various trainings for the Afghan militaries. President Ilham Aliyev said Azerbaijan will continue its assistance to Afghanistan until 2014, and if necessary will spare no effort in the future.

### Azerbaijani delegation takes part in 5th Astana Economic Forum

May 22 (AzerTAc). A delegation led by Samir Sharifov, Finance Minister of Azerbaijan, has participated in the fifth Astana Economic Forum (AEF) dedicated to the challenges and prospects of world economic development in terms of global transformation. The event is co-organized by the support of the "Eurasian Economic Club of Scientists" Association operating in Kazakhstan. Presidents, heads of transnational corporations, representatives of political and business communities, scientists in economics, Nobel Prize winners as well as Robert Mandell, Robert Aumann, Christopher Pissarides, the former Italian Prime Minister Romano Prodi, British former Prime Minister Tony Blair and Wim Kok former Prime

Minister of the Netherlands and other officials are among the attendees of the forum.

This year's agenda of the 5th Astana Economic Forum includes three sections: financial capital and global economy, industrial-innovative development, sustainable development and global social situation. In total, the agenda of the forum consists of over 50 panel sessions of different formats with the participation of more than 8,000 delegates from 90 countries. President of the Republic of Kazakhstan Nursultan Nazarbayev and Turkish Prime Minister Recep Tayyip Erdogan will attend the official opening ceremony.

### Air Astana starts flights on Astana-Baku route

May 22 (AzerTAc). On May 21, Kazakh Air Astana Company launched new flight on Astana-Baku-Astana route, Company's Baku office reported. The flights will be implemented by Embraer 190 aircrafts and on Monday and Friday. Company has leased 4 Embraer 190 aircrafts to implement flights in Central Asia and CIS and signed contract to purchase such type of aircrafts. First aircraft will be delivered to the Company in July. Ticket for economy-class starts from AZN 200, for business-class – from AZN 450. The price includes airport charges and other taxes. The tickets for both directions cost AZN 376 and AZN 886. The flying time is 2 hours 55 minutes.

### Elmar Mammadyarov: Azerbaijan's Achievement

May 23 (AzerTAc). "Hosting Eurovision in Baku this year helped Azerbaijan demonstrate its progress which the country managed to attain through the years of independence." The statement came from Azerbaijani Minister of Foreign Affairs Elmar Mammadyarov in the article published in The Wall Street Journal. "As host of this year's Eurovision Song Contest, my country can showcase the progress it has made since independence," the minister says. "Azerbaijan's pride in hosting the 2012 Eurovision Song Contest, which has the largest television audience of any non-sporting event in the world, reflects far more than a love of music. It signals my country's re-emergence into the international community and enables us to showcase our achievements since independence," the minister explains.

In the article Mammadyarov speaks about a turning point in the history of the country during the USSR collapse and the restoration of national independence, war with its neighbour Armenia and implications of this war including millions of refugees and the occupation of Nagorno-

Karabakh region, the overcoming of political and economic crisis of that period by Azerbaijan which thus made its way to economic growth and prosperity.

"Today, in 20 years after gaining independence, Azerbaijan has become one of the fastest economies in the world where the average annual growth in GDP in 2003-2008 made 20%", Mammadyarov said noting the great role of the national Oil Fund and the reasonable economic management. "Azerbaijan has managed to combine the rapid economic growth, including the steady growth in non-energy sector, with economic and political stability", the minister says.

## U.S. Congressman Gregory Meeks wished Azerbaijan success in Eurovision 2012 song contest

May 23 (AzerTAc). Member of the U.S. House of Representatives, Gregory Meeks wished Azerbaijan success in the 2012 Eurovision Song Contest. The congressman said the international contest in Baku is an opportunity for a wider audience to become acquainted with Azerbaijan. U.S. congressman Gregory Meeks was one of the many speakers, representing the Congress at a two-day conference devoted to 20th anniversary of diplomatic relations between Azerbaijan and the United States in Washington. Addressing the conference Meeks said, "There has to be a continued dialogue engagement for the next 20-30-40-50 years. One of the most serious cases, we face is a strong and knowledgeable U.S. ambassador in Baku. I express my gratitude to the organizers of a conference, American and Eurasian Council «Turquoise», U.S. Azeris Network (USAN), the Institute «Caspian Strategy» and the School of Advanced International Studies at Johns Hopkins University. I can see that the conference is attended by many of my colleagues in the Congress. This indicates that we are always thinking about you. Regardless of political affiliation, the U.S. Congress members know and support the important role of Azerbaijan in the region. In order to live in a more stable world, our relations in the region should strengthen. I hope that in the framework of inter-parliamentary ties we should expand our dialogue with Azerbaijani colleagues and increase mutual visits of delegations. During these visits we gain new knowledge and new friends. We have planned these visits. In conclusion, I wish your country success in hosting the Eurovision Song Contest "Eurovision-2012". I know that it will be a good opportunity to

showcase the talents of not only Azerbaijan, but also throughout Europe. We also look forward meeting new talents during the competition. In general, the contest in Baku is an opportunity for a wider audience to get acquainted with Azerbaijan. The more we know about you, the more we talk about the importance of our relations with your country with our voters. Once again thank you for the invitation to the conference. As a member of the Subcommittee on Europe and Eurasia of the U.S. Congress, I hope, we will be working and talking closely and make a visit to the region soon."

### **INTERPOL Secretary General visits Seaside National Park in Baku**

May 23 (AzerTAc). Secretary General of INTERPOL Ronald Noble has visited today here the Seaside National Park. Executive Director of the Heydar Aliyev Foundation, Anar Alakbarov told Ronald Noble that one of the priceless gems of Baku, the Seaside National Park, is a fine example of Azerbaijan's material culture. It is also a special natural complex that forms the historical and modern appearance of the capital. The rapid socioeconomic development of the country under the leadership of President Ilham Aliyev in recent years has significantly changed Baku, turning it into a metropolis. The changes have not bypassed the Seashore National Park. The urban planning, recreation and tourism infrastructure coupled with the environmental safety of the beautiful capital have enhanced the opportunities for implementing the Seaside National Park development strategy. The Secretary General was told that the available 450-meter pier has been extended into the sea by another 100 meters. In the future, the length of the boulevard will be increased to 25 kilometers. The expansion of the Seaside National Park was also intended to improve conditions for boat tours, for which three new boats have been brought to the capital. Then Noble became familiar with the Baku Crystal Hall, the venue of the Eurovision-2012 Song Contest. He was told the hall can seat 25,000 people and has an original architectural style that imparts special beauty to the capital. In the future, it can host other international events. One of the factors increasing the value of the Baku Crystal Hall is its proximity to the State Flag Square. The Secretary General of INTERPOL also visited the National Flag Square. He was told that President Ilham Aliyev signed an Order on establishment of National Flag Square in Baku on November 17, 2007. The same day, the President signed another order to declare November 9 as the National Flag Day.

The foundation stone for the National Flag Square was laid on December 30, 2007 with the participation of President Ilham Aliyev. The inauguration ceremony opening of the National Flag Square took place on September 1, 2010. Confirmed by the Guinness Book of Records, the flag flies on a pole 162 meters high and measures 70 by 35 meters. The upper part of the Square embraces three hectares and overall the square covers 60 hectares. The square features the state symbols of Azerbaijan (the coat of arms and the anthem) and the map of the country. Noble also became familiar with the National Flag Museum established on the initiative of President Ilham Aliyev. The museum features flags and emblems of states existed in the territory of Azerbaijan as well as khanates, constitutions of Azerbaijan adopted in past years, postal stamps, banknotes, orders, medals, flags kissed at the inauguration ceremonies by national leader Heydar Aliyev and President Ilham Aliyev, flag of Supreme Commander-in-chief and ceremonial costumes. The museum also showcases a Guinness World Records certificate for the tallest flagpole, books photographs and flag hung in the embassy of the Azerbaijan Democratic Republic in Turkey. The Secretary General told journalists the Azerbaijani President, Government and people can be proud of the high-level organization of the Eurovision-2012 song contest. He noted over a short period Azerbaijan had achieved great accomplishments. Noble also said those coming to the Baku Crystal Hall would feel themselves safe.

### Azerbaijan shows off its culture to Europe

May 23 (AzerTAc). Europe has witnessed the greatness of Azerbaijan's culture as the country has played host to a grandiose first semi-final of the Eurovision-2012 song contest. Millions of people across Europe along with audience at the Baku Crystal Hall watched Natig, an Azerbaijani national rhythm group, perform in the interval todav's of show. act The performance featured a tambourine stone (Gaval Dash), the oldest musical instrument ever discovered in Azerbaijan, as well as several other traditional instruments including a tar, a kamancha (both string instruments), a balaban and a zurna (wind instruments). They performed a yally, which is a traditional Azerbaijani round dance, and young drummers were conveying messages through drum beats.

### Spanish Parliament rejects "Armenian genocide" recognition

May 24 (AzerTAc). The Foreign Affairs Committee of Spain's Parliament refused to recognize the so-called "Armenian genocide" by 36 votes against and 3 in favor. The two MPs from the Amaiur coalition from the Basque Country prepared draft proposals for the recognition of the 1915 events as genocide during the Ottoman Empire period. The proposal was supported only by the Basque Nationalist Party and United Left. The Spain's ruling centre-right People's Party, Socialist Workers' Party and others opposed the document. Speaking at the Commission's session Jose Maria Beneyto, MP from the People's Party, and Meritxell Batet, MP from the Socialist Workers` Party cited France as an example to claim that such steps can damage the Turkish-Armenian relations. MP from the Progress and Democracy party Irene Lozano has condemned those who proposed this document, adding it would be better to mourn terror act victims in the Basque country rather than to talk about the "heroism" of Armenians and shed crocodile tears for them. "I see these actions as duplicity. And the thing is that you protect Armenians," Irene Lozano said. The role of the Embassy of Turkey in Spain in securing the refusal by the Parliament was noted.

### The Telegraph: Baku, Azerbaijan: Dubai of the Caucasus

May 24 (AzerTAc). "The Telegraph" published an article entitled "Baku, Azerbaijan: Dubai of the Caucasus". The article says that "The oil-rich city of Baku is a suitably surreal venue for this year's Eurovision contest". The author underlines that "Oil-soaked earth had long been used as a fuel in Azerbaijan, but it was the drilling of the first commercial oil well in 1846 that led to a massive influx of opportunists. A new city, conceived in the grand European style, sprang up around the sleepy, walled old city of Baku - now a UNESCO-listed world heritage site. In 1991, Azerbaijan won its independence from a crumbling Soviet Union and the country's rebirth began. In 1994, Heydar Aliyev, father of the nation announced a contract with a European oil consortium, which he trumpeted as the "deal of the century". This launched Azerbaijan's economy upwards, hauling the country headlong into the 21st century". "Now, no fewer than five new international hotel brands are opening properties of predictably lofty proportions. Baku aspires to be the Dubai of the Caucasus. Baku is a city like no other. And there is so much more than the brash and glitzy glass towers. There's the grand Boulevard, mazelike Old City, stuffed with cafés and carpet shops. The Modern Art Museum is impressive – more so than the world's tallest flagpole. It has nine of the world's 11 possible climatic zones. There are significant prehistoric stone carvings; a vast new billion-dollar (reputedly) ski resort; half the world's mud volcanoes, Day-Glo pink salt lakes, burning mountain sides, flaming rivers and springs".

### Azerbaijan assumes PABSEC presidency

May 24 (AzerTAc). Azerbaijan took over the presidency of the BSEC Parliamentary Assembly from Armenia at the 39 plenary meeting of the Parliamentary Assembly of the Organization of the Black Sea Economic Cooperation (BSEC) in Yerevan. Azerbaijan was represented by delegation led by BSEC Vice-President Asef Hajiyev, MPs Musa Guliyev and Jale Aliyeva. May 23 meeting discussed and unanimously adopted a statement on the 20th anniversary of the Organization. The statement in particular, confirmed that the main objective of cooperation within the BSEC is development of good neighborliness, friendship and partnership between the countries of the region, mutually beneficial cooperation in political, economic and humanitarian spheres. The Parliamentary Assembly of BSEC welcomes effective cooperation in the field of transport, trade, energy, communications, tourism, environment, health, agriculture, and fight against organized crime. The statement expressed readiness to strengthen cooperation for peaceful and stable development of the region. The 40th meeting of the BSEC Parliamentary Assembly will be held in Baku on November 21-22.

## US Department of State: Armenian separatists continue to control most of the Nagorno Karabakh region of Azerbaijan

May 25 (AzerTAc). The Armenian separatists with support of Armenia continue to control most of the Nagorno Karabakh region of Azerbaijan, US Department of State said in its annual report on violation of the human rights in different countries for 2011. The document says during a year the incidents along the frontline separating two parties of the Nagorno Karabakh conflict have continued with huge death toll on both sides.

## Eurovision to allow Azerbaijan to become closer and more understandable to ordinary European citizens, Matthew Bryza

May 26 (AzerTAc). The Eurovision will allow Azerbaijan to become closer and more understandable to ordinary European citizens, who today have the wrong idea about this country, thinks Matthew Bryza, former US Ambassador to Azerbaijan. He said thousands of Europeans arrived this week in Azerbaijan to watch Eurovision song contest. He noted those who know Azerbaijan mainly from elegant commercials on CNN will see in the

capital, Baku, a developing city graced with a stunning promenade along a turquoise sea. According to him, for today most of the Europeans know about Azerbaijan only from the reports and articles by the Western media. As a person who served a one-year term as US Ambassador to Azerbaijan, I know that they often do not reflect the reality, he said. Bryza underlined that "Azerbaijan's record on economic reform has been significantly better than is portrayed in the Western media. Economic reformers have followed prudent fiscal and monetary policies". He said: "Azerbaijan's society, government reformers invested much of the country's energy revenue in an anti-poverty program that helped reduce the poverty rate from 49 percent to 9.1 percent from 2003 to 2009 (16 percent, according to the World Bank)".

## Nabucco consortium to make final decision on Shah Deniz project this summer

May 26 (AzerTAc). Shareholders of Nabucco and Shah Deniz consortium are currently negotiating together in order to find the most appropriate option for both sides. Nabucco consortium presented proposal for the basic version of the pipeline to Shah Deniz-II consortium in September, 2011. And an updated version on Nabucco West has been submitted in May, 2012. According to the Nabucco Gas Pipeline International GmbH operator, the consortium is expected to make final decision on Nabucco-West project this summer. The Nabucco Consortium presented on May 17 a revised, smaller version of the gas pipeline project called Nabucco West to the consortium developing the Shah Deniz II gas field in Azerbaijan. The 1300-km pipeline Nabucco West is to carry Caspian gas from the Bulgarian-Turkish border to the Central European Gas Hub (CEGH) in Baumgarten and beyond. The Nabucco group said that the revised version of the project would benefit from the existing legal framework such as the Intergovernmental Agreement, Project Support Agreements and third party access exemptions, that have already been negotiated.

The original pipeline was 3,900 kilometers long and ran from the Eastern border of Turkey to Baumgarten in Austria. The Nabucco project aimed at lessening Europe's energy dependence on Russian energy was supposed to achieve a gas transport capacity of 31 billion cubic metres (bcm) a year. Nabucco competes with a number of rival pipeline projects for Shah Deniz II gas. The Shah Deniz II Consortium is to announce a winning project in the summer, a final investment decision due in 2013. Nabucco's shareholders are Austria's OMV, Germany's RWE, Hungary's MOL, Turkey's

Botas, Bulgaria's Bulgarian Energy Holding (BEH) and Romania's Transgaz. MOL and RWE have questioned the feasibility of the original version of Nabucco, threatening to leave the project company.

## Azerbaijani President watches grand final of Eurovision-2012 song contest

May 27 (AzerTAc). Azerbaijani President Ilham Aliyev, his spouse Mehriban Aliyeva and family members have watched the grand final of the Eurovision-2012 song contest in Baku. A lavish firework display marked the opening of the Eurovision-2012 final show at the Baku Crystal Hall. The 46 countries. grand final broadcast live to European Twenty-six countries were competing for the title of winner of the 2012 Eurovision Song Contest. Prominent mugham singer Alim Gasimov was first to impress the audience with a mugham piece. Last year's winner duo Ell & Nikki opened the show with the Running Scared to the accompaniment of Azerbaijan's national musical instruments. Following the ceremony, the 26 acts competing in the grand final of the 2012 Eurovision Song Contest took the stage of the Baku Crystal Hall. Then, the voting started to decide the winner of the grand final. The result was determined by way of a 50/50 split between national expert juries and televoting. The combined scores created the final outcome. Countries awarded their votes in scores from 1 to 7 and then 8, 10 and 12 points with only the latter three being read out by the spokesperson. All 42 participating countries were able to vote. The televoting was held during the live show once the final performance took place. The viewers of the 26 competing nations had the opportunity to televote for their favourite song with the numbers being revealed by their respective national broadcaster during the live show. The lines were open for just 15 minutes after the last song was performed. Famous singer and songwriter Emin Agalarov presented an original and a spectacular show involving a 68-man group of back vocalists and dancers at the interval act of the grand final, definitely making the audience go crazy on the big night. Sweden was crowned the winner of this year's Eurovision song contest. Loreen was voted Europe's favorite, after scoring 372 points with her song Euphoria.

Russia's Buranovskiye Babushki ranked second, followed by Serbia's Zeljko Joksimovic. Azerbaijan's Sabina Babayeva came 4th scoring 150 points. Four countries – Ukraine, Malta, Turkey and Lithuania – gave maximum of 12 point votes to Azerbaijan.

The grand final culminated with a press conference of the contest's winner. Speaking to the press conference, Loreen said: "I loved the people of Azerbaijan, they are very friendly."

She thanked the host Azerbaijan for excellent organization of the contest.

### 94th anniversary of Azerbaijani Democratic Republic marked in Toronto

Under the UN Charter, the Security Council has the primary responsibility for the maintenance of peace and security in the world. The Council presidency rotates among its members in the English alphabetical order of their names. Each president holds office for one calendar month. China previously assumed the presidency in March 2011. The Security Council has 15 members, including five permanent members — China, Britain, France, Russia and the US. The 10 non-permanent members are elected by the UN General Assembly for two-year terms. Azerbaijan will take over the presidency of the Council for the next time in September, 2013.

### Baku-Gabala-Baku flight launched

June 3 (AzerTAc). Azerbaijan Airlines has opened a direct flight from capital Baku to Gabala and back. According to the company, the flights will be carried out on Fridays and Sundays. The flights will be operated by ATR-72 crafts.

The one-way ticket costs AZN48, the company said.

Gyongyosi expressed hope the Nagorno-Karabakh conflict would be soled peacefully.

### Azerbaijan's Premier meets members of Council of Elders of Turkicspeaking countries

June 7 (AzerTAc). Prime Minister of Azerbaijan Artur Rasizade met Thursday delegates who are in Baku to attend the next gathering of Council of Elders of Turkic-speaking countries. During the meeting they said relations between Azerbaijan and Turkic-speaking countries were developing successfully. The Prime Minister noted despite the financial crisis in European countries Azerbaijan's economy is continuously developing. He also noted Azerbaijan's military power was strengthening day-by-day. Rasizade also spoke of Azerbaijan's increasing profile in the region. would be solved soon. Members of the Council of Elders of Turkic-speaking countries said Azerbaijan was developing rapidly. They expressed confidence that political, economic and cultural cooperation between Azerbaijan and Turkic-speaking countries would further expand. They also thanked the Azerbaijani leadership for conditions created for holding the gathering.

## We believe that occupied territories of Azerbaijan will be liberated, says Turkish President

June 8 (AzerTAc). Turkish President Abdullah Gul speaking on Friday in Igdyr said he believes the occupied Azerbaijani territories will be liberated. "Peace will be established in the Caucasus, Turkey is making every effort to create the atmosphere of stability in the region," Abdullah Gul said, according to Anadolu agency. Peace will be established in the Caucasus, and all problems will be forgotten after solving the Nagorno-Karabakh conflict, he added. "We are doing our best to establish stability in the Caucasus," he said.

The conflict between the two South Caucasus countries began in 1988 when Armenia made territorial claims against Azerbaijan. Armenian armed forces have occupied 20 percent of Azerbaijan since 1992, including the Nagorno-Karabakh region and 7 surrounding districts. Azerbaijan and Armenia signed a ceasefire agreement in 1994. The cochairs of the OSCE Minsk Group - Russia, France, and the U.S. - are currently holding the peace negotiations.

Armenia has not yet implemented the U.N. Security Council's four resolutions on the liberation of the Nagorno-Karabakh and the surrounding regions.

### Speaker of Azerbaijani Parliament meets Chairman of Kazakh Senate

June 8 (AzerTAc). Speaker of Milli Majlis Ogtay Asadov has today met with Chairman of Kazakhstan's Senate Kayrat Mami. The sides discussed development of relations between the two states, including expansion of the interparliamentary ties. Kayrat Mami noted that Kazakhstan feels proud with dynamic development of Azerbaijan. The Speaker of Milli Majlis said thanks to the efforts of Azerbaijani and Kazakh Presidents, relations were rapidly developing.

## Germany recognizes Azerbaijan's territorial integrity, Horst Schnellhardt

June 9 (AzerTAc). "German Bundestag adopted a resolution on Azerbaijan's territorial integrity two years ago and expressed its positive position to the effect. I want to confirm once again that in this resolution Germany recognizes Azerbaijan's territorial integrity and supports its just position. This is an official political position, we absolutely maintain it," visiting German member of the European parliament Horst Schnellhardt said. The European MP said he would share his impressions on Azerbaijan, as well as all information with his colleagues. "Certainly, we will raise the issue again. It is important for both Azerbaijan and us. This problem is one of the moments impacting us". "The European MPs are concerned about the situation in Azerbaijan's frontline area, as well as Armenians' gunfire on Azerbaijani farmers, civilians working in the agricultural fields", he added.

### Foreign Ministers of Azerbaijan, Georgia and Turkey meet in Trabzon

June 9 (AzerTAc). Ministers of foreign affairs of Turkey, Azerbaijan and Georgia got together over a tripartite meeting in city of Trabzon, Turkey, on Friday to assess bilateral and regional developments. Turkish Foreign Minister Ahmet Davutoglu, Azerbaijani Foreign Minister Elmar Mammadyarov and Georgian Foreign Minister Grigol Vashadze discussed opportunities to improve cooperation between their countries during the meeting, Azerbaijani Foreign Ministry's press service said. "This tripartite dialogue mechanism, established between the foreign ministers of Turkey, Azerbaijan and Georgia upon our country's initiative, is expected to provide a platform to discuss bilateral and regional issues and to develop an understanding of cooperation on various fields based on mutual benefits," the press service reported. As is stated, the mechanism also aims at contributing to regional stability and security by creating an atmosphere of sustainable regional cooperation in the South Caucasus.

# Georgian Foreign Ministry: Karabakh conflict threatens security of entire region

June 11, AzerTAc. The conflict in Nagorno-Karabakh is not conducive to security in the region, deputy Minister of Foreign Affairs of Georgia Nino Kalandadze said at a news briefing in Tbilisi on Monday, answering a question about the escalation of tensions on the border between Azerbaijani and Armenian troops. Kalandadze said the security situation in South Caucasus "is very fragile" due to existing conflicts in the region. "The international community knows it however and in the first place, leaders of the three South Caucasus countries know about it," the deputy minister noted. "I am confident that all parties fully understand how the Karabakh problem is complicated, how serious the consequences of armed conflict would be for the entire region and how difficult a situation in the region it can be in terms of the development of our countries," she said. Kalandadze noted that there is always a theoretical risk of an escalation of tensions under current conditions to which all must be sensitive. "I am convinced that the both states are sensitive to this issue," Kalandadze said, stressing that the Georgian authorities are in constant contact with Baku and Yerevan.

The conflict between the two South Caucasus countries began in 1988 when Armenia made territorial claims against Azerbaijan. Armenian armed forces have occupied 20 per cent of Azerbaijan since 1992, including the Nagorno-Karabakh region and seven surrounding districts. Azerbaijan and Armenia signed a ceasefire agreement in 1994. The co-chairs of the OSCE Minsk Group - Russia, France, and the U.S. - are currently holding the peace negotiations. Armenia has not yet implemented the U.N. Security Council's four resolutions on the liberation of the Nagorno-Karabakh and the surrounding regions.

### Turkey-Azerbaijan-Georgia business-forum held in Kars

June 11 (AzerTAc). Turkey-Azerbaijan-Georgia Business-Forum was held in Turkish city Kars. The Forum was organized by Azerbaijani Ministry of Economic Development, AzPromo (Azerbaijani Export & Investment Promotion Foundation), Turkiye Odalar ve Borsalar Birligi (TOBB) and Turkish Foreign Economic Relations, and Georgian Invest in Georgia National Investment Agency. As is stated, the Forum is being held trilaterally with the initiative of Azerbaijani President Ilham Aliyev. The Azerbaijani delegation headed by Minister of Economic Development Shahin Mustafayev and comprising officials, as well entrepreneurs engaging in industry, agriculture, construction, tourism, energy, bank, finance, information-communication technologies, logistics and other spheres attended the event.

Turkish Economic Minister Zafer Chaglayan noted this forum as an example of Azerbaijan-Turkey-Georgia friendship and informed about current economic links among the countries and development of cooperation. Turkish Minister also noted that as long as Armenia does not withdraw from occupied territories in Azerbaijan, Turkey will not establish relations with Armenia: "Turkey always supported Azerbaijan and will support forever". Azerbaijani Minister of Economic Development Shahin Mustafayev noted that, Azerbaijani President Ilham Aliyev attached importance to sustainable development of political and economic links with both Turkey and Georgia and stressed that Azerbaijan-Georgia-Turkey collaboration was a model in the world: "Baku-Tbilisi-Ceyhan, Baku-Tbilisi-Erzurum, East-West transport corridor, Baku-Tbilisi-Kars transnational projects, implemented for realization of our countries' economic potential, conditional geographical position, great transit opportunities, change the region to the important ring of profitable economic cooperation between Asia and Europe". Mustafayev noted that, during 4 months of 2012, Azerbaijan's trade turnover with Turkey rose 60%, with Georgia – 15% in comparison to a year earlier. At present, 1,106 Turkish investment-based companies operate in Azerbaijan and at the same time, 844 Azerbaijani investment-based companies operate in Turkey. Turkish investment in Azerbaijan makes \$ 1.9 bln, investments of SOCAR and other companies in Turkey are approximately \$ 4.5 bln. SOCAR's investments will make \$17 bln until 2018: "272 Azerbaijani investment-based companies operate in and \$ mln invested during Georgia 454.5 were 1996-2011". Business forum lasted with bilateral meetings among the businessmen.

### Azerbaijan's first lady honored with "First Lady of the Year" award

June 13 (AzerTAC). In accordance with the poll conducted by influential Turkish magazine "Ekovitrin", the first lady of Azerbaijan, President of the Heydar Aliyev Foundation Mehriban Aliyeva became the winner in the nomination "First lady of the year" for 2011. Welcoming the winners and guests, the owner of the magazine Kamran Abachioglu briefed the audience on poll conducted by the magazine. He stated that the poll has lasted for two months and 102 figures of politics, business, arts and science received 251,562 votes in 34 nominations. Secretary General of the Organization of Islamic Cooperation (OIC) Ekmaladdin Ihsanoglu and Kamran Abachioglu handed over a prize "First lady of the year" to Anar Alakbarov, the executive director of the Heydar Aliyev Foundation, intended for President of the Foundation, UNESCO and ISESCO Goodwill ambassador Mehriban Aliyeva. Turkey's Minister of Culture and Tourism Ertogrul Gunay received "The Minister of the year" award, while OIC Secretary General Ekmaladdin Ihsanoglu was awarded in the "International diplomacy" nomination. The rectors of Turkey's influential universities Mustafa Aydin, Sezer Shener, owner of "Calik Inshaat" Company Ahmad Calik, the mayor of Istanbul's Shishli district Mustafa Sarigul were among the laureates.

## Azerbaijani parliament adopts law on ensuring security of expresident and his family

June 12 (AzerTAc). The parliament of Azerbaijan adopted a Constitutional Law on ensuring security of ex-presidents of the Republic of Azerbaijan and their families.

The law will be implemented in respect of the persons taking the office of the president in the past except the presidents ousted in accordance with Article 107 of the Constitution. Since there are no such cases in Azerbaijan, the law will be implemented in respect of all expresidents. The law gives some privileges to the ex-presidents and their families.

The law consists of 12 articles. According to the Constitution, expresidents are the persons taking the office of the President of the Republic of Azerbaijan in the past, the persons, who died during the office or ended the office in accordance with Article 104 of the Constitution. The law also has the articles concerning the ex-president's spouse and children, adopted or stepchildren under age of 18. According to the law, amount of the expresident's pension is equal to 50 percent of his monthly salary during the presidency. The president impeached in accordance with Article 107 of the Constitution has no right to get this pension. The document also covers the allowance for the spouse of the deceased president and dependent family member. After the death of former president, allowance in the amount of 50 percent of the monthly pension is to be paid to the spouse or to the dependent child. If former president dies in office, the allowance equal to the president's pension is to be paid to the spouse or dependent child. If there is more than one dependent child, the allowance will be paid to them after being divided into equal parts. According to the law, the pension and the other payments must be paid to the ex-president from deserting his presidential post till his death. If the ex-president dies, it must be paid to the spouse of the ex-president, to the child until he or she reaches 18. In general, the payment of pension and grants and other provisions will be considered in the state budget. The pension and grants paid to the expresidents are free from tax. The clauses of any law and rules on medical supply determined for civil service will also concern ex-president and his (her) family members. The law considers to give 3 security staffs, one driver, one service car, the payment of representation expenses in amount of 20% of monthly salary of person, who is in the presidential post, and to give a diplomatic passport for life to ex-president and his (her) spouse. Expresident can not be brought to administrative or criminal responsibility for the acts made before his (her) election or during fulfilling its obligations. His (her) spouse will not be brought to the demonstrative and criminal responsibility for the acts made by ex-president during the period of fulfilling the obligations or previous periods. Ex-president can't be brought to responsibility, detained, examined without the consent of the General Prosecutor except the detention on the scene of the crime. According to the law, the archive consisting of copies of personal correspondence documents is kept in ex-president's order.

### 11th International Transport Exhibition kicks off in Baku

June 12 (AzerTAc). Today, the press conference dedicated to the opening of the 11th edition of TransCaspian, the International Transport, Transit & Logistics Exhibition and 2nd Caspian International Road Infrastructure and Public Transport Exhibition was held at Trend news agency's press centre. The exhibition will be open on June 13 at Baku Expo Centre.

This year, over 70 companies from 15 countries are set to exhibit, with the exhibition's floor space growing by 25%. Several Government bodies will take part alongside the commercial companies, including the Ministry of Transport of the Azerbaijan Republic, Azerbaijan Railways CJSC, the Azerbaijan State Caspian Sea Shipping Company, and the State Road Transport Service of Azerbaijan Republic.

# Azerbaijani FM hold discussions with President of International Court of Justice

June 13 (Xinhua). Azerbaijani Foreign Minister Elmar Mammadyarov met with President of the International Court of Justice Peter Tomka, the Ministry told media on Wednesday. Tomka Mammadyarov about the structure and jurisdiction of the International Court of Justice, about the cases, which are currently under consideration and the transformation carried out in the court system. Tomka thanked Azerbaijan for the support. The Minister, in turn, emphasized that Azerbaijan as a democratic country with respect for the rule of law is a proponent of settling international disputes and conflicts on the basis of international legal principles and standards, supports the activities of the International Court of Justice as a full member of the United Nations. Other issues of mutual interest were discussed during the meeting.

### Bishkek to host discussion on prospects for development of relations between members of TURKPA

June 14 (AzerTAc). The Azerbaijani delegation headed by Speaker of the Milli Majlis Oqtay Asadov visited Kyrgyztan to attend the third plenary session of TURKPA.

The Azerbaijani delegation included head of the Milli Majlis Administration Safa Mirzayev, Chairman of the Parliamentary Culture Committee Nizami Jafarov, MPs Ahliman Amiraslanov, Sevinc Fataliyeva, Ganizade. Gulivev Sadagat Chingiz Ulvi and The Azerbaijani delegation has been welcomed at the Manas International Airport by Deputy Chairman of Jogorku Kengesh (unicameral parliament of Kyrgyztan) Asia Satikbaeva, TURKPA Secretary General Ramil Hasanov, Azerbaijani Ambassador to Kyrgyzstan Arif Agayev and other officials. The meeting will feature discussions on the development of interparliamentary relations between the members of TURPA and other important issues. It is also planned to approve the draft budget of TURKPA for 2013.

### Ankara's 636th avenue named after Khojaly

June 14 (AzerTAc). The 636th avenue of Mamak, a metropolitan district of Ankara, Turkey, was given a name of the Azerbaijani town Khojaly, according to the Azeri Embassy in Turkey. The decision was made May 12, 2012 to perpetuate the memory of the victims of terrible massacre committed by the Armenians in the Azeri-populated town Khojaly, located in Nagorno Karabakh region of Azerbaijan (now occupied by the Armenian Armed Forces).

Khojaly Avenue is one of the largest avenues of Mamak district binding Ankara's Shakhintepe, Shirintepe, Misket and Dutluk areas. The initiative was launched by the Commission of Ankara Municipality and accepted by a majority of 82 voters.

## International Bank of Azerbaijan finances construction of largest textile plant in Middle East

June 14 (AzerTAc). The International Bank of Azerbaijan has financed the construction of Middle East's largest textile factory in the Emirate of Fujairah of United Arabian Emirates. Chairman of the Bank's Board Jahangir Hajiyev, Ruler of the Emirate of Fujairah Sheikh Hamad bin Mohammed Al Sharqi, Emirate's Minister of Industry and Economy Sheikh Saleh bin Mohammed Al Sharqi, Chairman of Fujairah Free Zone Authority Sheikh Saif

bin Hamad Al Sharqi participated in the opening of the factory. The factory's construction budget is \$ 60 mln. The factory with the annual production capacity of 10,000 tons will employ 225 people. The factory was provided with the German equipment. The goods to be produced in the factory will be exported to European and Asian countries.

### Azerbaijan, Kyrgyzstan discuss deepening relations

June 15 (AzerTAc). On the sidelines of the third plenary meeting of the Parliamentary Assembly of Turkic-Speaking Countries (TURKPA) in Bishkek, speaker of Azerbaijan Milli Majlis Ogtay Asadov has met speaker of Kyrgyz parliament - Jogorku Kenesh Asilbek Jeenbekov. The sides discussed a number of issues, including how to deepen relations between Azerbaijan and Kyrgyzstan, expand interparliamentary ties and develop cooperation within TURKPA. They noted a lot of work had been done for development of cooperation among member states of TURKPA during Kazakhstan's presidency in the organization.

## OSCE praises adoption of National Action Plan on Protection of Human Rights in Azerbaijan

June 15 (AzerTAc). Vice-speaker of Azerbaijan Milli Majlis, head of parliamentary delegation to OSCE Bahar Muradova met Thursday OSCE Chairperson-in-Office, Ireland's minister for foreign affairs and trade, Eamon Gilmore. Muradova said her country puts emphasis on development of relations with OSCE on the level of government, parliament and civil society. "We think that these relations will contribute to development of and multilateral cooperation." Muradova achievements were made in Azerbaijan in building civil society, holding transparent elections, ensuring rule of law after the country joined the OSCE. She pointed out there were some factors to impede strengthening security both in the country and region and one of them is Armenia-Azerbaijan, Nagorno Karabakh conflict. "Official Baku regards decisions adopted in OSCE's summits and Parliamentary Assembly as efforts towards settlement of the problem. Unfulfillment of these decisions means that OSCE has not completely implemented its mission. "We are satisfied with the principles announced by the OSCE and Minsk Group co-chairs, documents signed by presidents, 4 resolutions adopted by the UN Security Council on the conflict, but what does not satisfy us is lack of concrete result. If we take into consideration the opportunities of international organizations, we can say that there are ways of solution to the problem. The main issue is that political will must be demonstrated. We hope that

your visit to the region, your statements will have results." Eamon Gilmore, in turn, praised the progress done in Azerbaijan to develop civil society and ensure human rights and liberties. He particularly highly appreciated the adoption of the National Action Plan on Protection of Human Rights. Gilmore said there was freedom of speech, pluralism in Azerbaijan. The Chairperson-in-Office expressed concern over recent tensions on Armenian-Azerbaijani frontline. "Ireland has suffered conflicts as well. We understand very well that such problems must be solved soon. The OSCE plans to take some measures to settle this conflict." During the meeting the sides also exchanged views on development of draft law on Defamation, preparation for the upcoming elections, cooperation with OSCE's relevant institutions, joint activity in law-making process and other issues of mutual interest.

Kazakhstan ranks 2nd in world in terms of e-participation

GENEVA. May 16. KAZINFORM The delegation of Kazakhstan presented the achievements of the country in the sphere of information and communication technologies at the Forum of the World Summit on the Information Society in Geneva.

According to the latest rankings of the UN, Kazakhstan jointly with Singapore took the second place in the world in terms of the e-participation among 190 participating countries, Pm. kz site informed.

Kazakhstan ranked 31st in terms of these rankings in 2005. Our country also climbed up from the 65th place to the 38thone in 2005 in terms of development of electronic government.

Creation of the e-government in Kazakhstan was initiated by President of Kazakhstan Nursultan Nazarbayev. The program on introduction of e-government was approved on November 10, 2004 by the Decree of the President.

The web portal and the communication server of the e-government, electronic interdepartmental document circulation, certification centers, single transport sphere, state database of individuals and entities were launched from 2004 through 2006. www.egov.kz portal began its work on April 12, 2006 and when it was launched it rendered 377 information services of different state bodies.

The work on creation of the payment gateway of the electronic government which would allow conducting transactions had been held

from 2007 till 2009. Besides, the e-licensing database and the first interactive services were launched on the portal.

Presently, more than 2000 information, 225 interactive and transaction services are rendered within the framework of the e-government project. 154 120 users are registered on the portal and the average daily visits make about 25 thousand people. In total, more than 11 200 000 electronic services have been rendered over the last 6 years. Since April 1, 2012, all types of licenses are issues only in electronic format through the e-license portal.

As stated there, a Kazakhstan's representative will join the working group dealing with the construction of the refinery and raw material supplies.

Fitch forecasts 5 percent growth for Kazakh economy in 2012

ALMATY. May 16. KAZINFORM Kazakh economy could expect a growth of 5 percent in 2012, Charles Seville, director in Fitch Rating's sovereign team said Tuesday at the 6th Annual Conference of Fitch Ratings for Kazakhstan in Almaty.

"The oil revenues will contribute only 1 percent to the real GDP growth," he said.

According to him, the extractive industry is not growing as rapidly as the non-resource sector, Xinhua reports.

Kazakh economy grew 5.6 percent in the first quarter, while in 2011 the growth was 7.5 percent.

The Ministry of Economic Development and Trade has forecast an economic growth of 6 percent for 2012. The IMF recently raised its forecast from 5.9 percent to 6 percent.

OSCE Gender Adviser, in Kazakhstan, says women's rights essential for lasting security

ASTANA. May 16. KAZINFORM Miroslava Beham, OSCE Senior Adviser on Gender Issues, started today her visit to Kazakhstan during which she will discuss gender issues and exchange experiences with Kazakhstani officials, civil society, academics and journalists.

The two-day visit included a meeting with Gulshara Abdykalikova, Labour Minister of Kazakhstan who also chairs the National Commission on

Women and Family-Demographic Politics and members of the Majilis (lower chamber of the Parliament).

"A gender perspective is an important part of the OSCE's comprehensive approach to security," Beham said during the meeting with the Labour Minister. "If we want to achieve security and lasting peace in any society, we cannot ignore gender issues and women's rights."

"The national Strategy for Gender Equality is an important step taken by the Kazakhstan authorities towards achieving equal rights for men and women. However, there is still room for development, for instance regarding the representation of women in political life, especially in decision-making positions."

According to the OSCE Center in Astana, Ambassador Natalya Zarudna, the Head of the OSCE Centre in Astana who participated in the meetings, positively assessed the "fruitful longstanding co-operation with the Kazakhstani side". She said that "Kazakhstan's 33rd place among 154 countries according to the Gender Equity Index is a clear indicator of the progress made by this nation in promoting gender-balanced policy which the OSCE and the Commission have jointly contributed to".

Tomorrow Beham will travel to Almaty to deliver a lecture on the topic "Gender Issues as an Approach to Security in the OSCE Region" at the Al-Farabi Kazakh National University. On May 18 she will speak about the strategy and best practices in promoting gender equality in the OSCE region at a high-level conference on "Gender Aspects of Society's Modernization" at the Kazakh Women State University.

Both Chinese and foreign nationals have invested enormous amount of money in the Shenzhen SEZ. Shenzhen is now reputedly considered as one of the fastest-growing cities in the world.

Austria, Kazakhstan to develop coop in tourism

ASTANA. May 17. KAZINFORM Ambassador of the Republic of Kazakhstan to Austria Kairat Abdrakhmanov paid a visit to the federal state of Salzburg, press service of the Kazakh Foreign Ministry reports.

During his trip Ambassador Abdrakhmanov met with Salzburg Governor Gabi Burgstaller, vice president of the Salzburg Economic Chamber Peter Genser and heads of the leading industrial, transport and tourist companies.

Ms Burgstaller noted that Salzburg business circles were interested in cooperation with Kazakhstan and ready to share their rich experience in high technologies, software, telecommunications, renewable energy resources, food industry, tourism, etc. Kazakhstan is of particular interest to Austria as an energy supplier. (35 per cent of Austria's oil come from Kazakhstan).

The sides touched upon the opportunities for commercial and economic cooperation between separate regions of Kazakhstan and federal states of Austria.

Kazakhstan and Austria are also keen to promote cultural collaboration. Especially in terms of Salzburg Festival held annually in July-August under the supervision of Ms Burgstaller.

Special attention was paid to cooperation between Kazakhstan and Austria in tourism. The sides discussed possible training for Kazakhstani tourist staff at the Institute of Tourism and Hotel Management. This issue will be tabled in more details at the upcoming session of the Kazakh-Austrian Intergovernmental Commission for commercial and economic cooperation in Astana this autumn.

Senate approves bill combating money laundering

ASTANA. May 17. KAZINFORM Senate approved in the first reading a bill "On amendments to some legislative acts of the Republic of Kazakhstan on counteraction to laundering of illegally gained income and financing of terrorism."

While presenting the bill Kazakh Finance Minister Ruslan Dalenov noted payments between legal entities would be made only by bank transfers if the sum of a transaction exceeded the prescribed amount.

In addition, individual entrepreneurs and legal entities will be subjected to administrative sanctions due to lack of equipment designed to make payments via credit cards. It was also proposed to change the threshold values for transactions subject to financial monitoring.

Sarkozy hopes his successor will continue partnership between Kazakhstan, France

Nazarbayev received Kazakh Minister of Transport and Communications ASTANA. May 18. KAZINFORM Kazakh President Nursultan Nazarbayev has received Kazakhstan Minister of Transport and Communications Askar Zhumagaliyev, the Kazakh President's press service reported.

A Zhumagaliyev reported on the internet security and acceleration, the transfer of the state services to the electronic format and modernization of the public service centers.

According to A. Zhumagaliyev, the work on introduction of the CDMA technology continues. Communities of the villages of Almaty, Aktobe, Zhambyl, Kostanay, South Kazakhstan, Pavlodar regions have wireless broadband internet access due to the EVDO technology. Kazakh Minister of Transport and Communications has paid attention to the increasing number of the internet and e-government users.

Kazakhstan took the 38th place among the UN e-Government development rankings, and 14th in the on-line service.

Networked Readiness Index ranked Kazakhstan 55th . Kazakhstan has managed to achieve 46th position in the global Fixed Telephone Lines and 38th position in Mobile telephone subscriptions. 53% of Kazakh people use the services of the internet.

"Also, to date more than 1 million electronic signatures were issued," A. Zhumagaliyev said.

Till the end of the current year the Ministry of Transport and Communications is planning to convert 60 percent of socially important services to electronic format, and 100 percent in 2013.

The Minister also said that it is planned to put into service 998 kilometers of republican roads this year, of which 700 kilometers as part of the international transit corridor "Western Europe - Western China." Next year it is planned to launch 803 km international superhighway.

Zhumagaliyev informed that currently 158 technical inspection centers operate in the country. He also told about the beginning of testing the new system of technical inspection, which will allow to keep record of vehicles

that passed technical inspection, conduct multi-factor analyses and phasing out paper certificates.

The Minister presented to the President the plans on the development of sea transport and civil aviation. It is planned to buy 9 aircrafts till the end of this year and 8 more crafts in 2013.

Following the meeting Nursultan Nazarbayev gave specific instructions to the Ministry.

The design for a wind turbine that could work fairly efficiently at low speeds garnered Assiya Kussainova first place in electrical and mechanical

engineering. Most wind turbines don't generate power efficiently at wind speeds below 10 meters per second (and can't operate at all when wind speeds drop below 5 m/s), the young woman explains. But substituting long, rotating cylinders for the more-aerodynamic blades found on most standard wind turbines could enable the turbines to generate power at wind speeds as low as 3 m/s, her work indicates.

Apple Facts: Fruit, closely related to crabapples, originated in Kazakhstan NEW YORK. May 21. KAZINFORM Nearly every child has bitten into a crabapple (left) at some point and spit it back out--yuck! But a new study in *PLoS Genetics* shows that modern supermarket apples (right) are more closely related to crabapples than to other, better-tasting ancient species.

Apples originated in Kazakhstan, where they show incredible variety in taste and size, then spread along the Silk Road trading route thousands of years ago.

The Romans brought sweet apples from western Asia into Europe (Europeans previously used the fruit for cider), but the domesticated apple's history was murky after that. The new study looked at rapidly evolving DNA regions known as microsatellites in 839 apple samples representing five species ranging from Spain to China.

Testing these microsatellites allowed scientists to tease out the impact of recent crossings with wild apples. The researchers confirmed that modern apples were first domesticated from wild Asian apples, but they found that subsequent crosses with European crabapples--possibly selected for disease resistance, hardiness, or other traits--contributed the most DNA to modern domesticated apples, Huffington Post reports.

The scientists also found no evidence of genetic bottlenecks--a severe narrowing of genetic diversity--in domesticated apples, a pattern that contrasts with the earliest domesticated crops like barley, millet, and wheat.

Kazakhstan to spend 38 bln on single-industry cities development ASTANA. May 21. KAZINFORM KZT 38.2 billion are allotted for single-industry cities development in 2013, Minister of Economic Development and Trade Bakytzhan Sagintayev has told the Government's session today.

In addition, KZT 43.2 and 53.9 billion are to be spent on the same purposes in 2014 and 2015 respectively.

"The draft program suggests development of the package plans for towns not featured into the list of single-industry cities," B. Sagintayev added.

Large cities are to be financed using republican budget funds whereas financing for small towns will be provided by the regions. The implementation of the program is divided into two stages - 2013-2015 and 2015-2020.

Head of EDB: Common Economic Space of Russia, Kazakhstan and Belarus aimed at improving business climate

ALMATY. May 21. KAZINFORM The main objective of the Common Economic Space (CES) is to foster improvements in business environment for investors and entrepreneurs from the three countries and other states through the promotion of the free movement of goods, services, capital and labour. Igor Finogenov, Chairman of Eurasian Development Bank's (EDB) Managing Board, said this on Saturday at the session Russia, Kazakhstan,

Belarus: New Investment Opportunities within the Common Economic Space (CES) at the EBRD Annual Meeting in London.

According to the press service of the EABR, the head of EDB reminded that the CES member states had already adopted a number of agreements that coordinate their macroeconomic and financial policies, labour migration, the power sector, and technical regulation. Although significant mutual efforts and time are needed to implement them there are a number of arguments that the development of the CES will lead to improvements in business environment and foster economic growth.

This is primarily about the long-term effects of the CES on its member countries. According to a comprehensive assessment undertaken by the EDB Centre for Integration Studies in cooperation with Russian and Ukrainian researchers, the effect of the creation of the CES and Ukraine's subsequent joining it can reach US \$1 trillion for the four countries before 2030. This effect will produce an additional growth in Belarusian GDP of 14%, Ukrainian GDP of 6%, Kazakh GDP of 3.5%, and Russian GDP of 2%. Belarus, Ukraine and Kazakhstan are expected to benefit from integration to the greatest extent in terms of per capita effects and Russia in absolute terms.

Overall, the aggregate annual GDP of Russia, Kazakhstan and Belarus in the event of deeper integration within the CES is expected to be 2.5% higher than in the non-integration scenario. This will become possible due to greater accumulation of fixed capital, mutual investments and better competitiveness of the economies (because of a reduction in the share of primary resources in GDP), as well as the growth in trade within the CES and with its partners.

The adoption of a uniform migration policy will be a critical step in integration within the CES. «This is a key issue for the region's economies,» Igor Finogenov said. «For example, today labour migrants produce up to 6% of the Russian gross product.»

In addition, the CES will promote improvements in technical standards and technical regulation in the three countries, which will assist in their technological integration with the global economy. «There are 46 new regulations in the pipeline, a third of which have been already developed and adopted,» the head of EDB continued. «These are "newgeneration "regulations and standards that are compulsorily compliant with the WTO requirements and often harmonised with the standards of the European Union.»

Finally, further promotion of regional integration can result in the creation of a free trade zone between the CES and the EU, which will be of benefit to all its members due to the removal of barriers to the trade in goods and services, labour and capital flows, and intellectual property protection. «Its uniqueness and synergistic potential are based on the unprecedented size of such a regional union, which will unite the markets of thirty-one countries with a population of about 700 million and a GDP of more than US \$18 trillion,» Igor Finogenov concluded.

Nazarbayev: Kazakhstan enjoys partnership relations with France ASTANA. May 21. KAZINFORM Kazakh President Nursultan Nazarbayev received Total Executive Vice President Yves-Louis Darricarrere on Monday, the Presidential press service reported.

Kazakhstan, Russia commemorate 20 years of friendship, coop and mutual aid

MOSCOW. May 25. KAZINFORM Official visit of Russian President Vladimir Putin to Kazakhstan is one of key priorities for the short-term, Alexander Sternik, Director of the 3<sup>rd</sup> Department of CIS countries of the Russian Foreign Affairs Ministry, said in an interview to Kazakh mass media.

20 years ago, on the  $25^{th}$  of May 1992, Kazakhstan and Russia signed the Treaty on Friendship, Cooperation and Mutual Assistance between the countries. In 2002 the document was automatically prolonged for another 10 years because none of the countries expressed a wish to withdraw from the treaty.

"Over the period our ties and partnership have become more solid, we have passed the test of time and our relationship fully reflect interests of Russia and Kazakhstan. We have witnessed the growth in commodity turnover, strengthening of political interaction in the international and regional organizations and strategic leadership in the problems of integration in Eurasia," A. Sternik noted.

The diplomat also pointed out that Kazakh and Russian businessmen worked within a single space. "Kazakhstani businessmen are very active at the Russian market. The direct investments amounted to USD 200 million," Russian MFA representative stated.

"Right now we see a new integration phenomenon on the rise - single economic space. It is based on the Customs Union of Kazakhstan, Russian and Belarus," he said. "We are forming a single market covering 170 million consumers."

"Over the last two decades the CIS member countries have seen shattering changes. Thanks to wise leadership of President Nazarbayev and his colleagues in the CIS countries the implementation and deepening of the integration processes are of stable and gradual character," A. Sternik underlined.

"We bound not only by a centuries-long history but also by the largest border between the countries. We destined to be the closest allies and strategic partners," he added.

Kazakhstan, Norway discuss human rights

According to A. Volkov, the document numbers more than 160 pages and covers specific areas of bilateral cooperation.

"I would like to point out that we've made significant strides in negotiations. It was the first pilot round of talks. But the sides expressed a wish and readiness to make a compromise, concessions and find common grounds. I hope we will be ready to sign the new agreement after Kazakhstan enters the WTO," A. Volkov said.

He also stressed that Kazakhstani side put forward a number of specific suggestions in economic and bank cooperation, implementation of some agreements and expressed readiness to join the European conventions.

In his turn, Gunnar Wiegand, said the level of the second round of talks was high.

"We believe we will get our political, legal, commercial and investment relations and contacts up to the brand new level. Our citizens and business circles will benefit from it," EU representative added.

In addition, Mr. Wiegand expressed hope for strengthening of commercial and investment relations between Kazakhstan and the EU, especially in the light of upcoming accession of Kazakhstan to the WTO.

Within the negotiations the sides discussed all provisions of the future agreement embracing the problems of political, commercial and economic, legal, financial and humanitarian cooperation.

It is also worth mentioning that during President Nazarbayev's visit to Brussels in October 2010 Jose Manuel Barroso spoke in favor of expanding cooperation between Kazakhstan and the EU. According to the President of the European Commission, the EU was keen to develop relations with Kazakhstan in future.

"Malaysia's model is crucial to Kazakhstan's strategic planning. We have long-term bilateral relations between our president and (former prime Minister) Tun Dr Mahathir Mohamad," he said.

The recent exchange of visits by Malaysian Prime Minister Datuk Seri Najib Tun Razak and Nazarbayev would further create and give new impetus to foster relations between the two nations, he said. "We will work to implement similar policies which have been put in place in Malaysia. The similarities in approaches give us more perspective and space for mutual cooperation.

University accreditation system to improve quality of Kazakh higher education

The National Accreditation Council under the Ministry of Education and Science of Kazakhstan was established. "The institutions meeting the requirements of the national and international laws will make big contributions to ensuring the quality of higher education of Kazakhstan," M. Orukhanov emphasized.

It is worth noting that the universities of Kazakhstan are interested in receiving objective assessment of their activity from acknowledged accreditation agencies working in accordance with the Bologna criteria.

"We set as a priority a task on further joining the European system of quality assurance of higher education by these agencies. I believe that the accreditation agencies of Kazakhstan will be soon included into the European Register," the Deputy Minister added.

"It was a difficult day. There was a lot of wind and the rain was annoying, so we had to slow down the pace at the end," Kamyshev said through an interpreter. "At the end of the last lap, I attacked several times in order to stay well positioned for the sprint." Second overall last year, he believes his chances are good this year. It is indeed an admitted goal, Cycling News reports.

It was under an uncertain sky that the 88 riders started the 140.7 kilometres race taking Jonquiere's streets. Early in the race, a breakaway of three cyclists animated the stage. The fugitive trio was however caught

before completing the first lap. A few attacks were conducted during the next two laps, but none were successful.

Halfway into the race, two competitors took off from the peloton. Four cyclists who went to their pursuit soon joined them. The lead group had to surrender against a peloton at full blast. With less than 40 kilometres to complete, many attempted to breakaway, but on the seventh and decisive lap, all escapees had reintegrated with the bunch. A crash that occurred in the last kilometres blew the chances of some and tainted the event's outcome, which was finally determined in the sprint.

Kazakhstan may start building a nuclear power station jointly with Russia next year, President Nursultan Nazarbayev said yesterday in Astana after

meeting his Russian counterpart Vladimir Putin, Kazinform has learnt from Bloomberg.

Russia is also considering entering the Horizon project to build nuclear-power stations in the U.K., Kiriyenko said, according to Interfax.

The regional administration allocated KZT 1 million of financial assistance to the relatives of Kereyev, deputies of the Majilis and the West-Kazakhstan branch of "Nur Otan" Party helped the family of the deceased with KZT 200 thousand. In addition, Minister of Education and Science Bakhytzhan Zhumagulov on behalf of his family sent the Kereyev's family one thousand dollars.

#### 11 June 2012, 13:01

Kazakhstan wins the arbitration proceeding versus Caratube company ASTANA. June 11. KAZINFORM On 5 June 2012 the arbitral tribunal of the International Centre for Settlement of Investment Disputes (ICSID) adopted the decision on the case initiated by Caratube International Oil Company LLP (CIOC) against the Republic of Kazakhstan.

According to the press service of the Kazakh Justice Ministry, the amount of CIOC's claims was in excess of USD 1.2 billion. The ICSID rejected these claims and ordered CIOC to pay USD 3.2 million in favor of Kazakhstan as a compensation for arbitration costs.

The arbitral proceeding was initiated 4 years ago. The main hearings took place in Paris.

The dispute was related to the termination of the contract for the exploration and production of hydrocarbons in the Caratube oil field, which was result of CIOC's breaches and non-performance of the contract.

According to CIOC the grounds for this arbitration were the ICSID Convention and the US-Kazakhstan Bilateral Investment Treaty because of the US nationality of Devincci Hourani, the alleged owner of CIOC.

Although formally CIOC is owned by Devincci Hourani, the Tribunal rejected CIOC's arguments and found that it lacked jurisdiction. The Tribunal ruled that there was no proof that Devincci Hourani actually made investment and controlled CIOC.

The coordination of work on representation and protection of the Republic of Kazakhstan's interests in this arbitration was conducted by the Ministry of Justice of the Republic of Kazakhstan.

Kazakh President received Supreme Court Chairman

ASTANA. June 11. KAZINFORM Kazakh President Nursultan Nazarbayev has received Chairman of the Supreme Court of Kazakhstan Bektas Beknazarov, the Presidential press service said.

largest business partner of Kazakhstan. The commodity turnover between Germany and Kazakhstan amounted to USD 993.2 million in January-April 2012.

Russia, Kazakhstan, Belarus plan to boost sugar production 20% MOSCOW. June 12. KAZINFORM Sugar producers of the Customs Union of Russia, Kazakhstan and Belarus plan to increase output of the sweetener 20 percent to 6.7 million metric tons by 2020 from 2011, Russia's Sugar Producers' Union said on its website.

The increase will be achieved through better sugar-beet growing and storage technologies, the union said, citing its Chairman Andrei Bodin, Kazinform quotes Bloomberg.

"The plants on waste processing and tire recycling will be opened in Astana. These projects are a beginning of green business in the sphere of waste processing in Kazakhstan," the Minister said.

Besides, he informed that "Zhasyl Damu" Program for 2010-2014 was currently implemented. Within this Program, construction and reconstruction of waste water treatment plant in Aktobe, Uralsk, Aktau, Zhanaozen, Beineu, Kuryk and in Tugyl village in East Kazakhstan region

completed. Besides, implementation of the project on cleaning of the Komendantka river and the bed of the river Pionerskaya in East Kazakhstan region was completed.

Besides, the initiative on reforming the National Hydrometeorological Service - "Kazgidromet" into the company of global monitoring of soil, air and water including the Caspian Sea is being developed.

In this regard, the Ministry of Environment Protection of Kazakhstan plans to cooperate with non-governmental organizations which include more than 200 environmental ones. They take active part in development and implementation of environment policy, participate in the meetings held in the regions and their representatives are the members of the public environmental council under the Ministry of Environment Protection of Kazakhstan.

Besides, the Minister also informed about improvement of the legislation in this sphere. Thus, the Laws "On support of using renewable sources of energy" and "On energy saving" have been adopted and they will allow to increase the number of environmentally sound energy sources in the energy structure such as gas and renewable energy sources.

N. Kapparov also told about preservation of fertility of soil, water and biologic recourses. Moreover, using formerly inaccessible renewable energy sources will allow farmers to have always available energy and water independently which is also to increase export of meat, dairy products, fruits, vegetables and the other types of agricultural products.

"Woodlands play invaluable role for preserving environmental stability, water quality and water supply for the population. Protection and restoration of forests are priority directions they are supported at the international level by special financial mechanisms due to increasing demand for environmental services from woodlands for preserving climate and biodiversity," he added.

Kazakhstan and Germany to focus on economic cooperation priorities - Issekeshev

"Right now we are making the list of projects, continue the negotiation process," Asset Issekeshev said.

Presently, Germany is one of the main partners of Kazakhstan in Europe, and Kazakhstan is Germany's leading economic partner in Central Asia. The great impetus to the development of bilateral relations has been given by the visit of Kazakh President Nursultan Nazarbayev to Berlin early this year. The result of the visit was the signing of the partnership agreement in the raw materials, industrial and technological fields, and about 50 agreements totaling more than USD 3 billion.

"At present, most of them stopped their activity," Lama Sharif added.

102 Kazakhstani athletes qualified for Summer Olympic Games in London ASTANA. June 13. KAZINFORM 102 Kazakhstani athletes performing in 24 sports have qualified for the upcoming Summer Olympic Games in London, Chairman of the Agency for Sports and Physical Culture Talgat

Yermegiyayev said, according to the Kazakh Prime Minister's official website.

Speaking at today's press conference, the Chairman of the Agency said that the preparation of Kazakhstan national team for the main sport event was at the high level. Presently, 102 Kazakhstani athletes performing in 24 sports were qualified for the Olympic Games.

According to T.Yermegiyayev, last year, Kazakhstani sportsmen won 15 medals including 2 gold medals, 7 silver and 6 bronze medals and were ranked  $14^{th}$  in the global ranking in terms of the number of won medals and  $22^{nd}$  in terms of won gold medals. This was an essential increase in the performance of the athletes.

For example, in 2007, Kazakhstan team took the 42<sup>nd</sup> place in the global ranking.

Upon the completion of the press conference, Chairman of the Agency for Sports and Physical Culture Talgat Yermegiyayev and CEO of "Samruk-Kazyna" Fund Umirzak Shukeyev signed a memorandum of cooperation within the process of preparation for and participation in the 30<sup>th</sup> Summer Olympic Games in London.

In accordance with the memo, the Fund was named the official partner of the national team of Kazakhstan at the upcoming 30<sup>th</sup> Summer Olympic Games and the 14<sup>th</sup> Paralympic Games in London.

## 13 June 2012, 19:18

Kazakhstan plans to increase gold's share to 20% of reserves ASTANA. June 13. KAZINFORM Kazakhstan plans to raise the amount of gold it holds as part of its international reserves to 20 percent from 15 percent.

The central bank is buying 24.5 metric tons of gold this year, Bisengaly Tadzhiyakov, deputy chairman of the country's central bank, told reporters today in the capital, Astana. Its 98.2 tons held by April made Kazakhstan the 35th largest official sector owner of gold, between Poland and Australia, according to the World Gold Council, citing International Monetary Fund data.

Kazakhstan's gold holdings expanded by 16.2 tons this year through April, IMF data show. Central banks added 456.4 tons last year, the most in almost

five decades, and will buy as much as 400 tons this year, the London-based World Gold Council says, Kazinform has learnt from Bloomberg.

The banks are expanding reserves after the metal climbed the past 11 years and holdings in exchange-traded products are about 1 percent below March's all-time high. Investors have 2,386.717 tons in ETPs, exceeding official reserves in all but the U.S., Germany, the IMF, Italy and France. Gold makes up more than 70 percent of their reserves, except for the IMF, according to the World Gold Council.

Now its capital stock is \$26.3 million. 90 percent of bank's shares belong to international financial institutions, including the Aga Khan Fund for Economic Development, Habib Bank Limited, German Development Bank, European Bank for Reconstruction and Development and the International Finance Corporation.

# Kyrgyzstan's Foreign Minister proposes to consider the issue on the country's external debt in exchange for assistance to Afghanistan

Kyrgyzstan's Foreign Minister proposes to consider the issue on the country's external debt in exchange for assistance to Afghanistan. Mr. Ruslan Kazakbaev voiced the statement the day before in New-York (USA) delivering the report at the UN High-Level Thematic Debate on the State of the World Economy and Finance in 2012.

The official underlined the necessity to take unconventional decisions "which, first of all, will meet interests of several sides at once". According to the Kyrgyz Foreign Ministry, "one of such decisions is proposed to consider exchange of Kyrgyzstan's external debt for aid to Afghanistan".

Ruslan Kazakbaev also informed about measures taken for further development of international and regional integration, in particular, he mentioned the project on construction of Chinese – Kyrgyz – Uzbek railway with forming the southern corridor of Eurasian transcontinental railway. # Low rating of Vladimir Putin won't influence on Kyrgyz-Russian relations – Ishenbay Abdurazakov

"Low rating of Vladimir Putin won't influence on Kyrgyz-Russian relations," said Political Research Fund head Ishenbay Abdurazakov commenting Levada Center (Russia) social studies center data on Putin's rating decay.

According Ishenbay Abdurazakov Vladimir Putin's rating is falling because of current political and social reality in Russia. "Previous sanctity of power disappears. If earlier everyone thought that everything depends from

leader, today such opinion has changed. Russia is not some exception. Power vertical built around Putin can't "cover" all Russian citizens and solve their problems. The country is too big. Even a magician can't help everyone as well as Putin," consider the expert.

As he noted that some part of society will always wait from his leader much more. "Despite all his will and character Vladimir Putin can't realize all the expectations," said the fund head.

"In any case it won't reflect on us. We are dealing with the leader who will rule for a long period of time and we have to take it into account," he concluded.

Note, today Levada Center has published the results of sociological quiz taken place in previous years. As Kommersant newspaper writes the Russian President's rating fell down to 2000 index. Though, his popularity in ratings is rather high. Experts explain it with inaction of mass consciousness. Respondents give right answer on right question about elections or trust. When questions are out of policy a true mood of society reveals. Levada Center head Lev Gudkov notes that falling popularity of Putin doesn't mean disappointment in him of Russia's population. Only image of powerful and only leader disappears slowly.

### Foreign Affairs Minister assured OSCE that Kyrgyzstan "is open for discussion and suggestions on ethnic harmony"

Prosecutor demands 8-years imprisonment for him. Vladimir Farafonov is accused in stirring up national hatred.

# Kalykbek Sultanov: The Abu Dhabi Fund for Development will allot \$15 millions to Kyrgyzstan

"Under a loan agreement with Abu Dhabi Fund for Development Kyrgyzstan will receive \$15 millions to repair Dolon – At-Bashy section of Bishkek – Torugart road," the Minister of Transport and Communications, Kalykbek Sultanov, said today at the session of the parliamentary Committee on Economic Advancement.

According him, the total mileage of Bishkek – Torugat highway is 530 kilometers. "5 major donors of the Arab Coordination Group allot funds to repair 93 kilometers of a road sector. Agreements with the Saudi Fund for Development and the Kuwaiti Fund for Arab Economic Development are ratified. The Abu Dhabi Fund for Development is a third donor that will allot \$15 millions at 2 percent interest per annum for 15 years to repair Dolon – At-Bashy road sector. First 5 years will be grace period for Kyrgyzstan," said Kalykbek Sultanov.

MP Nurbek Alimbekov decided that 2 percent interest per annum is too high interest rate. But the Minister argued that all members of the Arab Coordination Group allocate \$72.35 million for highway repair. "We derive the average interest rate for the sum total. For example, interest rates make up 1.25-1.5 percent under two loan agreements ratified earlier," he explained.

MPs endorsed a draft project on ratification of loan agreement between the Kyrgyz Government and the Abu Dhabi Fund for Development.

### Kyrgyzstan gets ahead of Russia in the global Enabling Trade Index 2012

### Kyrgyzstan intends exporting meat to Saudi Arabia from September, 2012

Kyrgyzstan intends exporting meat to Saudi Arabia from September, 2012. Recently the Minister of Agriculture and Melioration Askarbek Dzhanybekov who met with this country's representatives said about this.

Reportedly, the purpose of the visit of Saudi Arabia's delegation is to review the agricultural sector of the Kyrgyz Republic in order to determine the further cooperation. Kyrgyz officials presented investment projects in the field of animal husbandry.

According to the head of the agency, Kyrgyzstan adheres to the principle of "open doors". "We have developed regulations that improve investment conditions. Preferential tax system is provided for small and medium businesses. Exports are exempt from VAT. Free export of currency is provided as well," he said.

"To create conditions for livestock exports development the Ministry intends establishing two logistics centers in the northern and southern regions of the country in which meat processing complexes will be built. They are expected to place near the airports of Bishkek and Osh cities. The country has over 9 million hectares of pasture and a favorable environment for the development of animal husbandry. Farmers need investments. Having funds they would be able to develop their farms. This would help increase the republic's export potential," Askarbek Dzhanybekov noted.

The members of Saudi Arabia's delegation said that they are interested in mutton first of all. "Later on it will be possible to export beef and poultry," the investor concluded.

It is specified that the parties have agreed on cooperation in the field of sheep breeding and to establish a working group that would work through these issues. Now they are visiting livestock farms of the republic.

## Turkish Airlines refuse to work in Kyrgyzstan due to the fact that officials of the Ministry of Transport demand free tickets

They said the officials of Ministry of Transport and Communications demanded free tickets," Zhoomart Otorbayev said.

He stressed that this is a defiant fact and "they should not simply dismiss these people, but raise the question of responsibility".

#### Premiers of Russia and Kyrgyzstan talk over issue on visits exchange

#### **Turkish Finmin Calls for Urgent Action on Eurozone Crisis**

Turkish Finance Minister Mehmet Simsek warned Tuesday that "a great fire" had engulfed countries using euro, saying the scope of the crisis called for urgent measures.

Speaking at a session at the World Economic Forum in Istanbul, Simsek said the crisis made banks in Europe "very fragile" which he said were already in peril due to toxic assets, adding that governments also faced a difficult financial bottleneck.

"Both governments and banks are weak. And you cannot expect banks to handle the situation on their own. The fire is spreading and it can hurt everyone. There is a need to contain the basic reasons of the fire," Simsek said.

Simsek said eurozone partners needed to take joint action and individual governments should take their own measures "in a structural transformation that could take years. And those measures need Germany to shift its stance on Europe." 06/06/2012

### Turkey Uneasy over Release of Suspects in German Neo-Nazi Murder

Turkey has expressed its concern over the release of three suspects in an ongoing case on the murder of eight Turks by an extremist right-wing group in Germany and called on the authorities to properly punish the criminals.

Releasing a written statement Tuesday, the Turkish Ministry of Foreign

Affairs said Turkey had been closely monitoring the investigation process launched by German authorities following the unveiling of the killing of eight Turks by the far-right German group National Socialist Underground (NSU) between the years 2000-2006.

The ministry said three of the suspects in the murder case had been recently released as they were deemed unlikely to escape, adding that such development had given rise to concerns over the potential release of other suspects in the future.

"It is our rightful expectation from the German authorities to conduct the investigation attentively and punish the criminals as deserved following a fair judicial process," the statement said.

In the same statement, the foreign ministry also condemned the recent attack against a mosque in the German city of Delmenhorst.

"It is a humanitarian duty and responsibility to preserve the sacredness of places of prayer regardless of the religion they belong to," it said.

The presence of the neo-Nazi cell called the National Socialist Underground was revealed last November when two members of the group were found dead after a suspected joint suicide and another surrendered to security forces.

It was unveiled that the cell had committed murders in several German cities without being detected by the German authorities for years.

The group is being held responsible for the death of eight Turkish and one Greek immigrant, as well as a German policewoman. 05/06/2012

#### **Turkish Support for EU Membership Drops Further**

Turks have grown less enthusiastic in the past six years over prospects to become the first-ever Muslim member of the European Union, data showed.

According to a collection of surveys by Turkey's statistics authority, support for the EU among young Turks plunged to 47.2 percent in 2011 from 74 percent in 2005. Among adults, support as well dropped from 63 percent to 44.3 percent.

Opposition to EU membership among young Turks almost doubled from 16.8 percent to 30.8 percent, and 27.6 percent of the adults said they would have voted against the accession if a referendum was held today.

Young Turks who said they had "no idea" about the issue was up from 9.2 percent to 22.1 percent.

Turkey applies for associate membership of the European Economic Community (EEC) in 1959. Turkey is a candidate country for EU

membership following the Helsinki European Council of December 1999. Accession negotiations started in October 2005.

So far, only one chapter (science and research) has been provisionally closed. Twelve more have been opened, but eight remain blocked by France, Austria, Germany, and Greek Cypriot Administration. 30/05/2012

#### **Turkey Considers Six-point Plan of Annan Last Chance**

Turkish President Abdullah Gul said that the six-point peace plan by UN-Arab League Special Envoy to Syria Kofi Annan was a last chance for the orderly transformation of Syria.

During his visit to Chicago for NATO Summit, President Gul replied to questions by Christiane Amanpour on CNN International.

In regard to the situation in Syria, Gul said, "We just wish to see people over there happy and prosperous. So we think that six-point Annan plan is a last chance for the orderly transformation of Syria. So that for we wish that this plan should be fully implemented. If it is not then unfortunately the problems will get even worse over there."

When Amanpour said, "It's not actually being implemented right now. Many, many more people are being killed," Gul said, "You are right."

Amanpour said, "So my question is how much longer, how many more deaths, how much longer do you think it'll take for Turkey to intervene or to persuade the rest of the world to intervene-" Gul said, "Well, it's a financial issue. That's why it has been taken in the U.N. Security Council and we have to be altogether and they think we should support legitimate right of the people and all of us, we have to stand behind the people's demand."

She said, "You know, Turkey talked about humanitarian corridors, buffer zones, all of those kinds of things. There's been a lot of talk from Turkey, but no real action in this regard. Are you waiting for something- Do you have to see the United States take the lead- What is it that you need before you can act-" President Gul said, "Well, I think United States is the most important country. They should engage more in this issue and we have to very closely follow the implementation of the Annan plan fully. Therefore, we need more

observers. This 300 is not enough. In fact, there should be several thousands over there."

Amanpour asked, "Are you trying to persuade Iran to try to talk to President Assad and convince him to step down-" Gul said, "Well, we are telling them that they should not keep the eyes blind, what's happening in Syria, because every day, many people are being killed and so far, even since the cease-fire is declared, more than 1,500 people lost their lives. So Iran should not carry the burden of this. So we are telling them that you should not support that. I think there is no any way that President Assad can lead the country any more."

Replying to a question on a resolution, Gul said, "Well, then of course the people of Syria, they will decide for this at the international committee will support them and will stand with them."

Upon a question on Turkey's relations with Israel, Gul said, "Well, you know, it was not our preferences and it was not because of us that the relationship deteriorated. So it's up to Israel. If the Israeli government, they want to correct, they pay some attention on the relationship with Turkey, they have to take some steps, which is known very well by them."

President Gul said Israel attacked the international humanitarian aid convoy and they killed nine people, stating that Turkey's legitimate demand was to get the apology and compensation.

Replying to a question on talks regarding nuclear program of Iran, Gul said, "The last meeting was held in Istanbul and it made some progress. There was a good climate at the both sides. They listened to each other and they understand after long time and they decided to go further. And I hope they will take some further step, because there is no alternative than the political solution of this problem."

Amanpour said, "And do you think the U.S. and its partners should allow Iran to continue enrichment or what- Or should it do what Israel wants, which says no enrichment, even for peaceful purposes- Gul said, "Well, I think it's their right, if it is peaceful and if it is transparent enough then it's their right, of course."

Asked what could be told the military in Egypt that it should leave the power, Gul said, "Well, the military is well aware that they cannot continue forever. I went to Egypt. I met with military officials and they know that it is not their job to run the country. They are going to hand over the authority to the civilians governments but I think it needs some time. They will have the election and then there will be authority there. So I think the Egyptian army is ready to hand over the authority when the time is proper."

Asked "do you really want to join the European Union, when you see the trouble that it has right now-" Gul said, "We are the part of the European custom union for 16 years. And we are negotiating country with the EU and we want to make progress in the process and we expect more reasonable understanding from our friends in Europe. The economic outlook in many countries in Europe is not good. We have a sound economy. Our cooperation will be helpful."

When she said, "So do you expect that now that President Sarkozy is gone and President Hollande is there that you will have a fairer, warmer hearing-"Gul said, "I think so. President Hollande is very reasonable and he has a very wide view. I hope the things will move smoothly." 26/05/2012

#### Bulgaria, Turkey, Qatar Agree to Build Highway

Bulgaria, Turkey and Qatar have agreed to form a common project company to build a highway on Bulgarian territory, the Bulgarian minister of regional development and public works said after a trilateral meeting May 24.

The cost of the four-year project is estimated at \$965 million.

The highway is planned to connect the city of Ruse by the Danube River bordering Romania to the city of Svilengrad right by the point where the borders of Turkey, Greece and Bulgaria meet.

"As decided at the meeting of the prime ministers of Bulgaria, Qatar and Turkey, we held a technical meeting over the construction of the Ruse-Svilengrad highway under the principle of the public-private partnership," Construction Minister Lilyana Pavlova told a news conference.

Last week, the premiers of the three countries agreed to study joint infrastructure projects, including construction of a new motorway that

would connect the Danube River Bridge to Istanbul, Turkey's largest city.

Pavlova said the road is expected to be completed in four years, and will cost around 1.5 billion levs (\$965.03 million).

"This is not an EU-backed project," said Bulgarian Prime Minister Boiko Borisov. "It will be realized as a joint project with the participation of the three countries."

Last Thursday, Qatar's Prime Minister Sheikh Hamad Bin Jassim al-Thani said the cash-rich country would deposit \$200 million into the Bulgarian central bank as a guarantee that it is serious about investing in the Balkan state.

Qatar said it would invest 100 million euros (\$127.08 million) over a year in agriculture, tourism, infrastructure and other projects in Bulgaria, the European Union's poorest member state. 26/05/2012

# Turkey Willing to Host a Center for Mediation and Coordination among Countries

Turkish Foreign Minister Ahmet Davutoglu said that Turkey was willing to host a center which would help coordination and mediation among regional organizations and states.

Speaking at the opening of a high-level meeting in New York on Wednesday, Davutoglu said that effective mediation was very important in preventing and solving the clashes.

Recalling that he, together with Finnish foreign minister, initiated "mediation for peace" 1.5 years ago, Davutoglu said that a resolution about this initiative had been adopted at UN in June, 2011 which was the first UN resolution accepted about mediation.

Davutoglu said that Turkey exerted many mediation efforts in Balkans, Middle East, Africa and Central Asia in the past ten years, and those efforts had a direct influence on the stability and prosperity of the countries.

Political outlook has completely changed after cold war, September 11 attacks, global financial crisis and political transformation process in the region, said Davutoglu, adding that Turkey, as a country in the middle of

these "earthquakes", felt responsible to undertake a more active role in order to better manage the course of events.

Our interest in undertaking a role of mediation is the natural result of these events, he added. 24/05/2012

### Fitch Says Turkish Incentive Program to Support Strategic, Large Scale Investments

International credit rating agency Fitch Ratings said Wednesday that an investment incentive program the Turkish government's recently announced would be beneficial for current strategic and large scale investments in Turkey from Turkish and foreign groups and provide further impetus for new or postponed investment plans in the slowing economic environment.

Fitch said, however, it would take time before the full effect of the new system on the competitiveness of Turkish corporates becomes evident.

Fitch said the government would provide strategic support through VAT exemption, export tax exemption, tax deduction, employment insurance support, interest rate support and VAT refunds and that the incentives could enhance some Turkish corporates' competitive advantage by providing lower labour and financing costs.

Fitch said the new incentive system differed from previous programs by aiming to reduce Turkey's dependency on imports, rather than providing financial support based solely on a geographic basis aiming to support under-developed regions in the country.

"It will focus mainly on sectors like energy, mining, auto, and tourism, which are considered the main sources of Turkey's wide current account deficit. As intermediate goods imports constitute 43 percent of Turkey's total production, the government is aiming to provide Turkish manufacturers with a competitive edge to reduce the portion of imports," Fitch said.

"Fitch believes the new incentive system could provide some support to petro-chemical companies, which are on the verge of making new investments. Petkim Petrokimya Holdings A.S. (Petkim; 'B+'/Stable) could be one of the companies that utilise the new incentive system, as

management is planning to increase capacity of its ethylene and PTA facilities capacity. The incentives could also support Turkeys AKSA's new carbon fibre investments, which are planned to reach USD1bn in the long term," the agency said. 23/05/2012

#### **Turkish Deputy PM Chairs OECD Ministerial Council**

Turkey's Deputy Prime Minister Ali Babacan is chairing the Organization for Economic Cooperation and Development (OECD) Ministerial Council meeting in Paris, France on Wednesday.

Turkey has been elected the rotating president of the OECD Ministerial Council in 2012. This is the first time Turkey is chairing the council in 26 years.

New approaches to fight against economic crisis, free trade system and employment-based growth, investments in employment, cooperation with strategic regions particularly North Africa and Middle East, development strategy, gender equality, skills and education, skills strategy are main topics of the meeting.

### Turkish President Meets Afghan, Azerbaijani, Macedonian Presidents

Turkey's president held talks on Saturday with his Afghan, Azerbaijani and Macedonian counterparts on the sidelines of a NATO summit to take place in Chicago.

President Abdullah Gul met Hamid Karzai, the president of Afghanistanwhich is one of the main topics of the NATO summit to begin on Sunday.

Gul later met Macedonian President Gjorge Ivanov and Azerbaijani President Ilham Aliyev.

During his meeting with Karzai, the two leaders referred to a friendship agreement signed between the two countries in 1921 and decided to speed up efforts to update the agreement.

Karzai thanked Turkey for its role in Afghanistan, and expressed concerns of his country to Gul, while Gul said he would express those concerns to leaders of other NATO members.

Gul highlighted Afghan-Pakistani relations, and Karzai thanked Gul for the trilateral meeting held in Istanbul in November among Turkey, Afghanistan and Pakistan.

President Gul later met Macedonian President Ivanov, who thanked Turkey for its support to his country's NATO membership bid.

Gul said Macedonia's membership process had to speed up after a ruling of the International Court of Justice that supported Macedonia's bid.

President Gul said Turkey would always support Macedonia, and underlined importance of accession of all Balkan countries to NATO.

Lastly, Gul met Azerbaijani President Aliyev, and congratulated him on his country's being elected the rotating president of the United Nations Security Council for May.

Gul and Aliyev discussed Baku-Tbilisi-Kars railway project, and they debated an article to be added to NATO final declaration on "long term disputes". Sources said the two leaders assumed a common stance on this issue. 21/05/2012

#### **Turkey Close to Azeri Gas Deal**

Turkey's energy and natural resources minister said on Friday that it would not be appropriate to say that the Nabucco project was over.

Taner Yildiz said the project would probably survive as "Nabucco West" - a smaller, shorter pipeline, widely thought likely to begin at the Bulgarian-Turkish border rather than in Azerbaijan.

"In the end I believe whatever the name of the project is, it is more important that it is do-able," Yildiz told an interview with the Financial Times.

Yildiz said it was more realistic to begin with the Azeri-Turkish route named the Transanatolian Pipeline, or Tanap - which could be linked up with another pipeline to bring gas to other European markets.

By the end of next month Ankara would conclude an agreement with Azerbaijan to set up a new pipeline to transport gas from the Caspian state's giant Shah Deniz field, Yildiz said.

"There is now no obstacle to the Shah Deniz project," he also said.

Yildiz's comments follow an announcement last month by Viktor Orbán, Hungary's prime minister, that Mol, the Hungarian oil and gas company, was pulling out of the Nabucco consortium. Mr Orbán said Nabucco was "in trouble", largely because of a rival pipeline promoted by Russia. Other companies in the Nabucco consortium, which include RWE of Germany and OMV of Austria, have already floated the idea of the slimmed down Nabucco west scheme.

Nabucco is the new gas bridge from Asia to Europe and the flagship project in the Southern Corridor. It will be a pipeline to connect the world's richest gas regions - the Caspian region and Middle East - to the European consumer markets. The pipeline will link the Eastern border of Turkey, to Baumgarten in Austria - one of the most important gas turntables in Central Europe - via Bulgaria, Romania and Hungary. When completed the 3,900 km pipeline's annual capacity will be 31 bcm. 18/05/2012

### Turkish President Approves Law on Sale of Real Estate to Foreigners

Turkish President Abdullah Gul approved on Thursday a law which envisages sale of real estate to foreign nationals.

According to the law, foreigners will be able to buy real estate in Turkey in line with the interests of the country.

The new law has raised the area of land a foreign buyer can purchase to 30 hectares from 2.5. The Turkish Council of Ministers may raise the amount of land a foreign buyer can purchase to 60 hectares.

Under the new legislation, foreign buyers must provide construction plans before a purchase is made.

Individuals and businesses will need to submit project proposals for vacant land to the Ministry of Environment and Urbanization within two years. If

approved, the project will be sent to the local land registry office.

The draft law also allows for the purchase of up to 10 percent of the total area of densely populated towns.

Foreign companies may purchase land only as allowed by laws.

The Turkish Council of Ministers may decide on which country's citizens or companies may be able to buy property and will determine the location and the size of the real estate. 18/05/2012

#### Turkey to Pay Off Debt to IMF by April 2013

Turkish Prime Minister Recep Tayyip Erdogan said on Tuesday that Turkey would pay off all its debt to the International Monetary Fund (IMF) by April 2013.

Delivering a speech at his ruling Justice and Development (AK) Party's parliamentary group meeting, Erdogan said that Turkey attracted an international direct investment worth 22 billion U.S. dollars in 2007 during the term of his party and it was a significant amount. Later Turkey attracted international direct investment of 18.5 billion USD in 2008, 8.4 billion USD in 2009, 9 billion USD in 2010 and 16 billion USD in 2011, he said.

In regard to Turkey's debt to IMF, Erdogan said that the country's debt to the Fund dropped to 2.3 billion U.S. dollars from 23.5 billion USD during the term of AK Party. "We will pay off all debt to IMF," he said. 16/05/2012
